<p>The university believes in the holistic development of its students through a multidisciplinary approach where the focus is on proper blend of curricular and co-curricular activities. It focuses on integration of knowledge and skills through its career oriented and skill development courses which promotes a multidisciplinary and interdisciplinary learning environment and a modern outlook as well as scientific temper. The University offers specialized programmes such as Social Work, NSS, International Relations and Entrepreneurship, to emphasize on giving back to the society.</p> <p>The University has been offering CBCS and a range of elective courses across disciplines in majority of the programmes that synchronises with the interdisciplinary approach suggested in the NEP 2020. In addition, as per the new NEP model, the University is also planning to offer multidisciplinary courses to the students, a multiple entry and exit and a choice of academic bank of credits in the coming academic years.</p>

<p>Academic Bank of Credits will provide significant autonomy to students by providing extensive choice of courses for a programme of study, flexibility in curriculum, novel and engaging course options across a number of higher education disciplines or institutions. With ABC, the University will be able to help students learn subjects of their choice and even do some courses from other institutions of their choice to achieve the best and become "skill-</p>	

oriented" graduates. The University is planning to implement the Academic bank of Credits. The registration process for the same is in the process.

#### **18.Skill development:**

Taking into consideration the objective of Skill development IISU is creating a workforce empowered with the necessary and continuously upgraded skills, Knowledge and internationally recognised qualifications to gain access to decent employment and ensure India's competitiveness in the dynamic global market. Operational Programmes of the university such as B.Com (H) Professional CA, CS and ACCA ;B.COM (H) Financial Markets, MBA ( Entrepreneurship and Innovation, Business Analytics, etc.) B.Sc., MA/ M.Sc./ M.Com in Fashion & Textile Designing, B.Sc. in Jewellery Designing , B.Sc. Multimedia and Animation, M.A. Clinical Psychology, Bachelor's & Master's degree programmes in Fine Arts, etc. are increasing the productivity and employability of workforce both in the organised and the unorganised sectors . For skill enhancement university is also offering UGC approved B.Voc skill-based programs in Digital Marketing.

#### **19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

Indian Knowledge System has been an integral part of the Curricular and Extra Curricular aspects at IIS (deemed to be University), Jaipur to ensure holistic development of its students and staff.

Since its inception, the University follows the age-old Indian tradition of greeting 'Namaskar' and also the custom of 'tika -moli' as a ritual of welcoming the guests. Several IKS based Career Oriented Skill Development (COSD), programmes such as Folk Dance, Kathak Dance, Vocal music, Yoga, etc are being offered by the university. In addition to courses on Yoga in Bachelor's degree programme, the Department of Physical Education is also offering a certificate programme in Yoga and is planning to introduce M.A./M.Sc. programme in Yoga in the academic year 2022-23.

The University regularly conducts IKS based activities such as Yoga and Meditation sessions, field trips, etc. In the academic session 2021-22, various IKS based significant events such as Hindi Bhasha Diwas, International Day for Yoga, National Unity Day, Constitution day, etc. were organised. In the cultural events held during the session, traditional/folk dances and music were showcased by the students of the University depicting rich and diverse Indian culture. Celebration of Hindi Bhasha Diwas at the University in

different forms, exhibition of Hindi books, novels, etc. and expert lectures by faculty to promote Hindi. Furthermore the University's NSS Unit organised XVII National Level Patriotic Solo Song Competition, Assamese Cuisine Competition, Assamese language learning activities, Documentary screenings of National heroes, etc. under the aegis of "Azadi Ka Amrit Mahotsav" and "Ek Bharat Shreshtha Bharat" with a view to cultivate IKS. Additionally, to forward Indian language and literature the University's Creative magazine L-link published poetry and prose in Hindi and other languages.

## 20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The university has taken extensive efforts in establishing an outcome based learning framework by designing program and course outcomes mapped with the educational objectives. The inclusion of choice based credit system (CBCS) is also one of the prominent endeavors taken by the university to strengthen outcome based education. The concept of flipped classrooms has been actively inculcated in teaching-learning pedagogy. Along with a well-designed system for continuous assessment, the university also pays heed to the feedback procured from various stakeholders in order to identify and reinforce the strategies to facilitate outcome based learning. Every department makes an effort to plan for the upcoming academic year focusing on soft-skill and vocational development of the learners. Teaching-learning strategies for achieving the desired outcome are part of the planning process. The assessment style is selected to complement the teaching strategy. The "Revised Bloom's Taxonomy" is the foundation for the TL method, assessment, and learning objectives. Expert talks were also organized to acquaint the faculty with the philosophy of outcome based education and computing of graduate attributes.

In order to bridge the gap between the academic and professional worlds, the university has designed and implemented specialisations in chartered accounting and company secretaryship, an MBA with dual specialization, a preparatory course for civil service, NET/SET.

## 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The learning levels of the students are assessed through regular classroom interactions, quiz/assignments and participation in curricular activities. To provide instructional support and enhance the intellectual independence of students, the University developed various measures. Advanced learners are encouraged to participate/present in seminars/ conferences. The faculty members provide the necessary support in writing/presenting academic research papers. To develop research acumen in advanced learners, the University encourages them to take up research projects funded by the University and/ or other funding agencies like the DST, etc. Students are provided additional reference books/back volumes of journals, etc. from the departmental and central library. A provision for freeships is available for competitive exam preparatory classes. The University awards fellowships, certificates and cash prizes besides felicitating academic toppers with Gold medals, merit certificates and Endowment medals. To promote peer-learning, slow learners are paired with advanced learners for various classroom activities, assignments and projects. Remedial classes and bridge courses of different subjects are held as an intervention to support students. Bilingual discussions are held after regular class hours for their better understanding. They are provided with individual counseling and life skills- coaching by an experienced Counselor at the University's Counseling and Career

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The University relentlessly focuses on developing confident students by honing their academic skills, through various student centric methods as a part of the curriculum:

**Experiential Methodologies:**

The students of Journalism and Mass Communication, Visual Art, Fashion and Jewellery Design who practice the skills in the state-of-the-art Audio Recording Studio and their respective studios.

Integrated B.A/B.Sc-B.Ed. programme and in certain COSD courses and in the Masters programme internships are a mandatory part of the curricula.

Extension Cell conduct, outreach/ extension activities for enhancing the 'student society connect', by providing on-the-job training and real-time experience of applied research.

Exhibitions and workshops are organized by the University to showcase the practical skills acquired during their course.

**Participative Methodologies:**

Management Games/Role Plays, Group assignments/Discussions/Presentations/Brainstorming Sessions etc. are used by the faculty members to promote peer-learning and strengthen team-work.

To gather knowledge about the latest advances in their respective fields, National/International conferences and seminars are organized.

#### Problem-Solving Methodologies:

Interactions with experienced resource persons through regular Guest Lectures/Expert Talks/Panel Discussion, provide an enriching insight into real-world scenarios.

The University promotes simulation exercises for helping students relate their classroom learning.

Case Studies are prepared and discussed by students on recent and relevant topics.

#### 2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

The University encourages optimum use of ICT-enabled tools for enhanced teaching-learning experience. It provides a holistic learning ecosystem for transforming teacher-centered classroom into a learner-centered one. High speed internet with lease line of 1 GBPS connectivity and available speed of 350 MBPS bandwidth speed with effective LAN networking is there for promoting paperless working. IISU Digital Library is an interface with over 9000 full-text journals, 80,000 audio-visual learning resources, 1,20,000 full-text theses, dissertations and 10,000 academic presentations. A full-time team of well-qualified IT, Web professionals to conduct regular training programmes for faculty members and students, to equip them with the functionality regarding the use of ICT for learning. Training on software such as MatLab, Avogadro, Quantum Espresso, WIEN2k etc. for academic and administrative purposes. Blended pedagogy adopted to enhance student-centered learning. The University is a nodal centre for IIT Bombay's outreach programme, Spoken Tutorial. Effective use of social networking platforms such as, LinkedIn, Facebook, etc. for educational purposes. In-house



examination software for managing the entire examination process. Computer-based exams for Foundation Courses in each semester, Research Entrance Examination for Ph.D. programmes. ICT assistance for faculty members in conducting real-time classroom assessments with educational applications such as Kahoot, Padlet, Google Quiz, etc.

The courses in each programme of study are designed keeping in view the Learning Objectives and are implemented only after the approval of the respective Boards of Studies and the Academic Council. These Outcomes are communicated to students through the syllabi uploaded on the University website.

The University has adopted direct measurement of PO, PSO and CO-attainment, wherein the attainment levels are measured by a robust evaluation pattern that includes both Formative Assessment (also called Continuous Assessment) of 30 marks (the distribution of marks is mentioned in the academic handbook) and Summative Assessment in the form of Semester End Exam for 70 marks. In Ph.D. programmes the weightage is 50:50.

In order to ensure that the defined POs, PSOs and COs are attained, a threshold value is predefined for every course. This value is the pass percentage of that particular course/ programme (36% for all regular UG & PG programmes, 40% for UG Honours, UG professional and PG professional programmes and 55% for Ph.D. Programmes. Course Outcome is said to be attained if students obtain marks equal to or higher than the predefined value. Course Outcome is defined at 4 levels of attainment, viz, 0, 1, 2 and 3.

The University has a well-defined research policy which provides a general framework for the promotion and conduct of research, in order to achieve excellence in research and to strengthen innovation.

Besides research projects sanctioned by external agencies, the University also provides research projects to faculty members and students. Besides fellowships sanctioned by various funding agencies, the university also grants Research Fellowshipsto scholars @ 6000/- per month and a contingency grant up to an amount of Rs. 15,000/- for outsourcing of facilities out of its own resources.

The University has constituted the Research Development Cell to facilitate the faculty members and students of the University. The facilities and infrastructure available at the University are incessantly updated and strengthened for the promotion of research activities. The R&D labs at the University have also been established with the purpose of initiating research in Life Sciences, Physical Sciences, Chemical Science and Home Science, and have been recognised under the "Scientific and Industrial Research Organisation" scheme of the DSIR, Govt. of India.

The University has a well-defined Consultancy Policy, "CONNECT," that strives towards making efforts for collaboration with industries, research centres, schools and organizations to facilitate a smooth linkage between the industry and the academia. It also aims to enhance employability and provide easy access for the conduction of applied research.

The University routinely teams up with several organisations from various industries to promote projects on Research and Development. It offers a wide range of areas for consultancy to faculty members.

The University also maintains a Consultancy Directory that lists the areas of expertise under which consultancy services are being offered and the details of the concerned faculty members involved in it. It is updated periodically with the inclusion of all high in demand consultancy areas, especially in the wake of the changing industry-scenario.

As per "CONNECT," the revenue generated from the consultancy provided by the faculty members is shared by them and the University on a 60:40 basis. To familiarize the students with the provision of consultancy, faculty members, and students together participate in a few paid consultancy projects and render their expertise. The industry-academia collaboration has proved to be highly beneficial, since the drafting of the Consultancy Policy.

The University spans across four Wi-Fi enabled campuses viz. Gurukul Marg (Main Campus), Mahaveer Marg, Sitapura, and the Kshipra Path campus.

- **Classrooms & Seminar Halls:** Spacious and well-ventilated classrooms and seminar halls, well-equipped with audiovisual aids. Seminar halls and auditoriums are used for organizing conferences, workshops, etc.
- **Laboratories:** Labs with adequate equipment- apparatus and proprietary software, Language Lab, Computer Science and IT Labs with reprographics facilities.
- **Media Centre:** Well-equipped Video Production studio and CRS FM7 studio maintained by full-time technicians.
- **Visual Arts Studios:** Sculpture, Painting, Applied Arts and Graphic studio, and a furnace room.



- **Central Library:** Centrally air-cooled, ICT enabled, wellstacked with books, magazines, periodicals, newspapers, journals, and e- research bases, previous years' question papers and answer-scripts. The University has membership of DELNET, National Digital Library of India (NDL), e-Shodhsindhu and Shodhganga.
- **E-library:** Equipped with computers meant for users to access IISU Digital Library, edatabases, e-books, e-journals, CDs/DVDs, etc.
- **ICT Facilities:** Wi-Fi and LAN enabled Campus and NKN leaseline with 1 Gbps connectivity speed and internet of 360 Mbps. Latest configuration computers and laptops are connected to the server centrally.

The maintenance of all the campuses of the University is done by a team headed by two engineers. Housekeeping Committee, Canteen Committee, Care taking Staff, IT Planning and Monitoring Committee etc. ensure the maintenance of University's infrastructure.

The University has AMCs for Refread, Library Automation Software, Pest Control, Solar Rooftop Plant, Elevators, Air-Conditioners, RO, etc.

The University ensures uninterrupted power supply and maintenance of electrical assets like generator sets and power distribution systems, as per their maintenance schedule and guidelines given by the supplier.

Fire-fighting equipment in various blocks, class-room, labs, hostels, offices, etc., is looked into via AMC. Further, a fleet of buses and cars is maintained by the Transport Office of the University.

All sports equipment is maintained by the Secretary, Sports Board; whereas Gym equipment is inspected annually by an external agency.

Regular maintenance of laboratories is taken care of by lab. technicians/assistants.

Inventory/Stock Register and Log Book for extensive and high-end equipment are maintained on a regular basis.

ICT facilities: The University has qualified team of Web Administrator, Software Engineer, Lab Assistants/ Supervisors for the maintenance and upkeep of computers, computer accessories.

- **Solid waste management:** Solid waste is collected in different-coloured bins (as per the SWM Rules 2016). Degradable waste from the kitchens of the hostel and Canteen is converted into manure using vermicompost techniques. Paper waste generated from office and examination department is handed over to a firm where it is recycled. Circulation of notices, duties and other important information through e-mail to minimize use of paper.
- **Liquid waste management :** Waste water is collected in a underground tank which is further utilized in watering the plants
- **Biomedical waste management:** generated from experimental animals and microbiological cultures is handed over to the firm Instromedex (India) Pvt. Ltd. Jaipur.
